

Martineau Place occupies a strategic location in the centre Birmingham forming part of the retail core and is adjacent to the main office district and future HS2 routes.

The centre comprises of over 430,000 sqft of space anchored by Sainsbury's, Boots & Poundland with other occupiers including Argos and Deichmann Shoes plus a 179 room aparthotel.

Originally constructed in the 1960's the scheme will shortly be the subject of a major reconfiguration and modernisation project offering a range of retail and leisure opportunities.

Birmingham has a shopping catchment of approximately 7.2 million people within a 1 hour drive. Located approximately 100 miles north of London and 70 miles south of Manchester, Birmingham is often referred to as the UK's second city with its profile set to be raised further with the planned HS2 rail project due to be delivered in 2026.
